## Frequent Questions and Answers (for Tourist visa only)

### 1, How long does it take to be issued my Indian visa?

After we received your required documents for India visa application, it would take about 10 to 15 business days to return your passport with Indian visa.  
It depends on the situation, your nationality, additional documents; we will inform you after you applied to our service.

### 2, How much we should pay for your service?

We will charge you the Indian visa fee of your nationality and ¥4775( Omakase A ) as our service fee additionally. We only accept to be paid in cash or into our bank account.

### 4, Is an original passport needed to apply for Indian visa ?

Yes, your passport should be valid for over 2 month and 2 blank visa pages.

When we applied for your Indian visa, your passport would be kept until the day of visa issuance at Embassy of India, Tokyo. Therefore, you might check your schedule carefully.

### **Please read before applying for your India Visa**

- 1 Our service will not guarantee to be issued your Visa.
- 2 It will take about 10 to 15 business days to be issued your Indian Visa. And we inform you that it may be happened delay to be issued your visa occasionally. It's your own responsibility when booking your trip.
- 3 In addition, if you had dual citizenship, the previous nationality, it may take more than 15 business days.
- 4 The postage costs related to send the documents to us from you when applying for your Indian Visa will be borne by yourself.
- 5 Cancellation after the arrival of the required documents to us, we will charge you 2100 yen as a cancellation fee.
- 6 If the refund amount is generated from us due to cancel, you will pay the transfer fee by yourself.
- 7 There are rare cases, Visas cannot be issued by Embassy of India, Tokyo in some cases. After we have processed your visa application, Our service fee and visa fees are not refundable in any reason.
